 - A. CCS BOM Meeting Action Items - actions taken, see Ex. A
 1. Baseball - BVAL AQ's - disapproved (Roll Call vote 38 to 11)
 2. Lacrosse
 - a) Split playoffs into 2 divisions - disapproved
 - b) Add 4 teams to D1 PO's - disapproved
 - c) Move AQ's around - disapproved
 - d) Align our PO's w/ NCS - disapproved
 3. BVB
 - a) Move AQ's around for Nor-Cals b/c we got 2 more - approved
 - b) Create CCS consolation matches - disapproved
 4. Softball
 - a) Expand CCS AQ's from 29 to 34 - approved
 - b) Move 2 AQ's from PCAL to BVAL - BVAL withdrew their proposal
 - c) Cut WBAL AQ's from 3 to 2 - approved
 - d) Rewrite qualifying language - approved
 5. T&F - unified events - approved
 6. B Tennis - align scoring w/ G Tennis - approved
 7. Article 22 - Participation Census - make this an annual requirement (and CCS/CIF considering adding a penalty for noncompliance) - send our delegates to CIF to vote “yes”
 8. Girls Flag Football - sent our delegates to vote “yes” - can play any season (Roll Call vote - 38 to 11) - CIF approved
 9. Golden Whistle Award - approved, will begin this Fall
 10. CCS BOM approved Assoc. Membership for Hillbrook School (SJ), will join WBAL eventually

- A. BOM Mtg. 1st Readings sent back to leagues
 - 1. Field Hockey - back to leagues
 - 2. GVB - change Open Div. to 2 pools of 4 teams each (decreases wait time) - back to leagues (LC's like it); similar to BB (decreases wait time)
 - 3. FB - back to leagues
 - a) #1 creates 2 champs within one division - called the "Open/Division 1 Championship"
 - b) #2 gives 4 AQ's to top 3 divisions, last AQ to some team from D 4 or 5
 - c) #3 is PAL AQ stuff
 - 4. Max Fee Schedule - see handout Ex. B; proposed for 3 years; sent back to leagues
 - a) CCS recommends the additional \$10 travel allowance
